Today in the NCCOEEE meeting held at 3:00 P.M, the decisions taken following the discussions among all the Federations and are as follows for implementation with full zeal and strengths;

All Constituent Federations take stock of the present position of EA Bill-2021 and felt that it is fairly likely that this will not be tabled in Lok Sabha in this monsoon session. So it's been felt that the energy accumulated not to be wasted without cause of action. However we can't sit idle and left the opportunistic window for Govt. of India.
