Sub: Strike Call of Uttarakhand Power Employees & Engineers wef October 06

Respected Sir,

You are kindly aware that Power Employees & Engineers of Uttarakhand Power Corporations are peacefully agitating for their long pending demands for a long time. Due to apathetic attitude of Power Corporation management and Energy department now they have been forced to proceed on an indefinite Strike with effect from 08 hours of 06 October.

- 2. All India Power Engineers Federation (AIPEF) wants to draw your kind attention towards the unpleasant situation getting developed in Power Sector of Uttarakhand due to stubborn attitude of top management of Uttarakhand Power Corporations.
- 3. Uttarakhand Power Employees & Engineers were getting three time scales after 09 years, total 14 years and total 19 years of service since UPSEB regime which continued after formation of Uttarakhand and was suddenly withdrawn in year 2017. Since 2017 Power Employees are getting three time scales after 10 years, 20 years and 30 years. You would kindly agree Sir, this is a gross injustice towards power employees. Power Employees have some other genuine problems of pay anomalies etc for which they are agitating.
- 4. On 27th July 2021 Hon'ble Energy Minister Sri Harak Singh Rawat himself held meeting with Uttarakhand Power Employees & Engineers Sangharsh Morcha at Dehradoon. I was also associated in that meeting. Energy Minister categorically assured Sangharsh Morcha on 27th July that Power Corporation level demands will be fulfilled within 15 days and Govt level demands will be fulfilled within one month particularly time scale demand of 09,14 & 19 years. Unfortunately till date nothing has been done.
- 5. Respected Sir! you are kindly requested to use your good offices and intervene immediately so that genuine demands of Power Employees & Engineers are fulfilled and unprecedented crisis in Power Sector of Uttarakhand is averted. I would like to intimate you that if Uttarakhand Power

Employees & Engineers are forced to proceed on Strike wef 06 October then Power Employees & Engineers across the country will fully actively support Uttarakhand Power Employees and no employee or engineer from other States shall be available for Uttarakhand to operate the Power System.
