

CIRCULAR

17th January, 2022

NCCOEEE National chapter met on 17th January on virtual platform to discuss and resolve the Agenda Notified through NCCOEEE Notice Dated 15th January, 2022. Shri Shailendra Dubey presided over the meeting.

1. Since, Government of India has stalled their activities related to legislation of the Electricity (Amendment) Bill, 2021 in the ensuing Budget session of the Parliament pending consultation with the stake holders, NCCOEEE decided to postpone the Strike Call on 1st February next. But all sorts of preparedness on the part of NCCOEEE constituents should be kept to fight all attempts of enactment of draconian Electricity (Amendment) Bill, 2021 in the second spell of the Budget session or any subsequent session of the Parliament.
2. NCCOEEE noted with grave concern that, even after shameful retreat of Government of India from the rapid activities of privatisation of J&K Transmission Assets through backdoor process of formation of JVC with PGCIL, under NM Pipeline, they have concentrated privatisation of other Union Territory Electricity departments, despite the fact that no laws of the land permits transfer of Government department including Government employees to private entity. Unlawful bidding process is being carried out for UT Chandigarh. in defiance of hold imposed by Hon'ble Chandigarh High Court. The Union representing employees of Chandigarh has unanimously resolved to call Strike on 1st February, 2022. United forum of Employees and Engineers of Pondicherry has also resolved to go for solidarity Strike in support of striking power employees of Chandigarh. In this circumstances, NCCOEEE decided to organise massive Nation wide Protest Demonstration on the day in solidarity support to Chandigarh as well Pondycherry power employees and engineers. All constituents of NCCOEEE will ensure participation of their members to the highest extent possible. Memorandum in more or less similar content addressed to the Lieutenant Governor of both the UTs will be sent from all states under NCCOEEE banner. President / General Secretary of the National Federations will be physically present at Chandigarh to address the massive demonstration there with mobilisation from the adjacent states like Haryana, Punjab & Himachal Pradesh. Similar mobilisation will also take place at Pondycherry. Electricity employees and engineers including NCCOEEE leaders from adjacent states will also organise mobilisation for demonstration to be addressed by regional NCCOEEE leaders. All mobilisation will take place with due compliance of COVID protocol.
3. NCCOEEE resolved to extend fullest support in true sense and spirit to Two Days' Nation wide strike on 23rd & 24th February, 2022 called by National Convention of Workers held at Delhi on 11th November, 2021 . All NCCOEEE constituent Trade Union members will take part in the Strike and all NCCOEEE constituent (NON TU) Association members (other than who are engaged in emergency operation) will take part in the demonstration in both the days through participation in Day Long Work Boycott.
