CONDEMN THE GOVERNMENT'S DECISION TO GO AHEAD WITH THE LIC IPO

The All India Forum Against Privatisation (AIFAP) strongly condemns the central government's decision to go ahead with the IPO of LIC despite the strong opposition of the workers of the insurance sector and a large number of policyholders of LIC. It has ignored all the apprehensions and pleas of workers and of people in order to benefit big Indian and foreign financial investors and institutions.

The government's claim that the disinvestment of 3.5% shares of LIC does not amount to privatisation is false. There can be no doubt that this disinvestment is the beginning of privatisation of LIC. As per the SEBI listing norms, the government will have to disinvest at least 25% of the shares of LIC in the next few years. Moreover, it is learnt that SEBI is considering raising the limit from 25% to 35%.

It is well known that once LIC shares are listed, the whole objective of the LIC will change from maximising the benefit to policyholders to maximising gain of the shareholders. The first step has already been taken by reducing the share of profit for policyholders to 90% from 95% to make the IPO attractive for investors. The share of policyholders is expected to further come down in coming years to increase the shareholder value. The Chairman of LIC has already announced that many other steps have been planned after the IPO to increase the shareholder value. LIC is likely to resort to riskier investments to maximise profit. Over 40 crore policyholders of LIC will be the biggest losers as a result of the IPO.

Over Rs. 35 lakh crore of assets of LIC have been built with the hard work of lakhs of workers and agents and the money of tens of crores of policy holders over 65 years. The government had put in only Rs. 5 crore of capital into LIC at the time of nationalisation. Only a few years back the government's investment in LIC was raised to Rs. 100 crore. LIC really belongs to its policyholders. The IPO ignores the interests of its real owners.

The focus of LIC after IPO will be to reduce cost so that profit can be increased. This will lead to remote areas and small policy holders getting deprived insurance as they are not very profitable. LIC had spread insurance widely in the country and among small policy holders due to which its average premium is Rs. 11,000 as against that the average premium Rs. 76,000 for private insurance companies due to their focus on large policy holders and cities. Workers will see their workload increase and numbers reduced due to privatisation.

The government has gone out of its way to help large Indian and financial speculators at the cost of crores of people availing insurance from LIC by rushing through the IPO and by drastically reducing the valuation of LIC. These speculators told the government to first postpone the IPO from March to a later date by giving the excuse of the Ukraine war. They then asked the government to reduce the valuation of LIC from Rs.16 lakh crore to Rs. 6 lakh crore. How can the value of LIC reduce to less than half in just two months? Once the government

agreed to the lower valuation, which meant substantially lower share price for the IPO, the government was advised to rush through the IPO even though the war is continuing! The government is getting deprived of nearly Rs. 35,000 crores due to reduction in the share price so that financial speculators can earn huge profit later when the LIC share price rises to its true value. The loss to the Government by this lowering of the valuation to favour speculators is another attack on the policy holders of LIC and the people of India.

The LIC IPO is undoubtedly an anti-people, anti-worker step to benefit big private Indian and foreign financial institutions.

We the members of the All India Forum Against Privatisation condemn the antipeople privatisation of LIC and other public sector enterprises. We are determined to strengthen our unity cutting across all sectors and affiliations and involve users and consumers to defeat the anti-people, anti-social and anti-national policy of privatisation.
