Bemlea Palakkad Indefinite Protest's Against BEML Privatization
Completes 500 Days On 24th May 2022.

&

People's Election On 19th & 20th May 2022

Dear Comrades,

You well know that Central Government had published EOI for Privatization of BEML on 04.01.2021. Therefore many of the Real estate, Road construction and non experienced corporate companies had submitted EOI and subsequently they had visited BEML complexes. The Corporate -servile Modi Government has been sold around 6 PSUs Including Air India ,CEL, Pawan Hans Limited etc to corporate with meager amount recently .Since from 2016, with the strong indefinite Protests by ours & National Trade unions and strong oppositions from State Government together helped to retain BEML as Public Sector undertaking under ministry of Defence .If the central Government sells BEML to private companies along with management control the following main difficulties might be faced by BEML Employees.

1. BEML Employees will lose status the **Government Servant** into Private Employee.
2. As a policy of privatization by Central Government, Government **will secure one year Job security** after the privatization, after completion of one year the Private Company will offer to us either permanent, fixed term or contract labours with new pay scale based on individual performance and by the manpower requirement policy of the private company.
3. After privatization the existing wage revision 2017 agreement, Promotion /annual increment scheme, increase / Decrease of DA every 3 months will be disappeared.
4. After Privatization, The private company can be borrowed bank loans over BEML Assets or can be sell BEML Land assets etc. It will put under panic in related to Job security till 60 / any time the closure of private company / crediting about monthly salary at month end etc.
5. The existing SC /ST /OBC Reservation for jobs will be ended.
6. The existing allowances, medical facilities, transportation facilities etc will be ended

Our indefinite Protests will be completed 500 Days on 24.05.2022. In the wake of completion of 500 day protests, we have decided to organize Two days Public awareness programs explain about importance of BEML in our National Security in the main streets of Palakkad Town on 19th & 20th May 2022.

Meanwhile we will conduct " **PEOPLE'S ELECTION** " in related to central Government decision of BEML Privatization among the Publics "whether the Central Government decision is correct or wrong?"


