Sub:-Regarding a Trackman of your Division Keyman Sri C.P. Sunil Kumar has died during his duty.

Dear Sir, we are regretting to say that this day is a very sad day for the Track maintainers of Indian Railway. Because one of our Track maintainer brother Key man Sri C.P. Sunil Kumar, 'Kollam' Section of your division has died while he performing his duty.

India's biggest Track maintainer Union AIRTU the National federation of all Track maintainers Trade Unions/Association of Indian Railway, requesting that according to Railway board order, RBE Letter No. 104/2019, that must provide Rs. 25000/- on the spot to the family of the deceased and we request that according to the Ref No. 2 the order of 7th CPC & according RBE Letter No. 139/2016, the Ex-gratia Rs.45 lakh should be provide to deceased family. Because according RBE Letter No. 2017/Transt.cell/CIVIL/03 dated: 05/02/2018, a safety tool of Uniform & Toolkit has not totally given yet. According to the RBE Letter No. 205/CE-11/TK/14 dated: 06/11/2018 & RBE No. 2015/CE-11/TK/14 Dated: 14/03/2022, the Railway Board ordered that "Safety of the worksites precautions", failure to fully implementing this rule in your Division has led to the death of our railway soldier. We request you that considering the railway track soldier (Track man) have died in the country's war & provide Ex-gratia maximum Rs.45/- Lakh to deceased family. In the Ref. No. 3 The Ministry of Labor & Employment has informed to Railway board that according to the Employment Compensation ACT 1923, that provide pension to deceased family by considering tenure of service of the employee. According to the Ref: No. 4 RBE Letter No. 32 we request provide pension to deceased family by considering length of service of the employee.

- \* In the Base of above RB Letters & In this Context Our Organization is placing the following Demands before you.:-
- 1) Rs.25000/- should provide on the spot to the deceased family.
- 2) The Body of deceased will be honored with all-state honors by draped with the Indian Flag.
- 3) Provide ex-gratia Maximum Rs.45/-Lakh to the deceased Family.
- 4) Provide Railway Job to deceased family.
- 5) Provide pension to deceased Family.

In this sad case Our AIRTU Organization heartily request to you that please do justice with deceased family & immediately fulfill our all demands.
