Sub: Meetings of Standing Committee on Energy of Parliament on Electricity (Amendment) Bill 2022.

List of Meeting of Standing Committee on Energy of Parliament is attached herewith.

2. As far as Electricity (Amendment) Bill 2022 is concerned till date 08 meetings have been done by the Standing Committee. First meeting was held on 01 December,2022 with representatives of the Ministry of Power. Reference of all the meetings held on Electricity (Amendment) Bill 2022 is as follows...

- 01 December, 2022 - Briefing by representatives of the Ministry of Power.
- 08 December, 2022 - Briefing by representatives of the Ministry New &

Renewable Energy and SECI.

- 25 January,2023 - Oral hearing of representatives of the Ministry of Power, Grid Controller of India, Power Grid Corporation of India Ltd and NTPC Ltd.
- 09 February 2023 - Oral hearing of representatives of the Ministry of Power, CERC & Forum of Regulators.

- 09 February2023 - Oral hearing of representatives of the Ministry of Power, Grid Controller of India Ltd, PGCIL & PTC India Ltd.

- 23 March, 2023 - Oral hearing of representatives of the Ministry of Power, CERC, Forum of Regulators and those Electricity Regulatory Commissions who have submitted memorandum to this Committee (Haryana, Chhattisgarh, Uttrakhand, Karnataka, Jharkhand, Kerala, Himachal Pradesh & UP).

- 27 April, 2023 - Oral hearing of representatives of the Ministry of Power, Department of Power (Govt of Kerala), Department of Power (Govt of West Bengal), KSEB Ltd and CESC Ltd.

- 25 May, 2023 - Oral hearing of representatives of the Ministry of Power, Ministry of Railways (Railway Board), Delhi Metro Rail Corporation (DMRC).

3. So as per the information available on website Standing Committee has done hearing with Ministry of Power, Ministry of New & Renewable Energy, Ministry of Railways (Railway Board), CERC, Grid Controller of India, Forum of Regulators, SERC of Haryana, Chhattisgarh, Uttrakhand, Karnataka, Jharkhand, Kerala, Himachal Pradesh & UP, Department of Power of Kerala & West Bengal Govt., CESC Ltd, NTPC Ltd, PGCIL Ltd, PTC India Ltd.

4. No hearing time has been given to All India Power Engineers Federation (AIPEF) or any other Federation of Power Sector Employees. None of the Consumers Forum have got the hearing time from the Standing Committee.

5. It is likely that the Ministry of Power may place the Electricity (Amendment) Bill 2022 in Parliament in coming monsoon session which is expected from 15th July. We are keeping watch on all the developments in this regard.

6. All State Constituents are requested to be ready for lightning action in case the Ministry of Power attempts unilaterally to rush through the Electricity (Amendment) Bill 2022 in the coming monsoon session of Parliament.
