Sub:- Intimation of a delayed long demonstration before SCCL office, Kothagudem and the Characteristics on 22.01.2024 pressing immediate redressal of long delayed grievances of retired employees of above company a Reg.

Dear Sir,

We on behalf of retired employees of SCCL wish to submit that we are finding serious hardships to lead our lives comfortably with meager pension, medical treatment, house plots etc., The CMPS – 1998 as never been reviewed and revised as per the Act consequently we are receiving meager pensions which is in no way suffice to lead our lives comfortably. Though we are all members of CPRMS but management is deducting 40% towards treatment charges at NIMS tariff, which is reducing from the total amount of rupees 4.0 lakhs per member and same may not long last forever. Further, there is a difference between retired executives and retired NCWA employees joined CPRMS who are getting each 12.5 Lakhs, while NCWA retired employees are allowed rupees 8.0 Lakhs together with husband and spouse, which ought to be brought on the same footing for availing the medical treatment at higher medical centers.

The following demands may please be addressed in order to remove the hardships of retired employees:

- 1. Immediate review and revision of existing employees by providing adequate fund to the present pension.
- 2. CPRMS in-respect of both executives and non-executives should be uniformly implemented without any discrimination.
- 3. All the retired employees should be covered under state's "Abhaya Hastam" to avail 6 benefits as introduced by the present ruling government at the state.

- 4. Streamlining CPRMS for non-executives, there is an urgent need of smooth implementation of Contributory Post-retirement Medical Scheme for non-executives and relevant amendment in medical attendance rules in the changed scenario for non-executives and amount towards CPRMS fop both retired executives and retired NCWA employees should be brought on same footing that is rupees 25.0 Lakhs for both executive and non-executives and their spouses towards treatment.
- The CPRMS card for availing medical treatment should be linked to Super Specialty Hospitals in greater cities.

Therefore, it is requested to look into the above genuine issues and see that they are addressed without further delay.
