SCRMU would like to bring to your attention several pressing concerns regarding the working conditions and equipment provisions for passenger train managers at the Secunderabad Depot. It has come to our notice that there are several challenges impacting the efficiency and safety of train operations due to inadequate supplies and outdated equipment. Addressing these issues promptly is crucial to ensure the smooth functioning of our railway services and the well-being of our staff.

Supply of low weight torch lights and tail lamps . 1. Train managers are required to carry safety equipment as the line boxes are withdrawn . The supplied low weight tail lamps and torch lights are over aged and

not working properly . Therefore it is requested to supply the new less weight torchlights and tail lamps to the above staff at the earliest.

- Replacement of Overaged Tabs and Power Banks: The tabs and power banks 2. supplied to train managers are overaged and no longer meet the necessary standards. It is imperative to replace these outdated devices with newer models to ensure efficient communication and operation during train journeys.
- Supply of New Walkie Talkie Sets: The current walkie talkie sets are also 3. overaged and are not functioning properly, posing a risk to communication among staff members. Supplying new walkie talkie sets is essential to maintain effective communication channels and ensure the safety of passengers and crew

6. Supply of Stationery Books and Forms: Guards' journals and other essential stationery books and forms have not been supplied for the last three to four years. This lack of necessary paperwork impedes proper record-keeping and documentation, affecting the overall efficiency and accountability of train operations.

We urge you to prioritize and address these issues with utmost urgency to ensure the safety, efficiency, and quality of service provided by the Secunderabad Division. Your prompt attention and action on these matters would be greatly appreciated.
