**Central Circular 04/2025 dte. 27/01/25**

**Dear Comrades,**

Sub: Proceedings and decisions of the CWC meeting held on virtual platform on 25/01/2025.

The CWC meeting of AILRSA was held on google meet on 25/01/25, was attended by about 95 comrades. All General Secretaries of all zones reported that the PROTEST DAY of 22/01/25 against the denial of 25% increase in running allowance rates, was a great success and gate meetings were held in many lobbies where we could not conduct any programmes in the past. Many speakers opined that it is right time we have to move beyond the conventional modes of agitation like dharna and hungerfast. It shows that the programmes of AILRSA central committee with the aim of an agitation of availing the basic rights by individual employees, as visualized in the concluding part of the booklet - Plight of Locomen is being accepted.

**Decisions**

The 24 hour' hungerfast decided by Patna BGM, shall be extended to 36 hours, from morning of 20<sup>th</sup> Feb. to 21<sup>st</sup> evening. All Loco Running staff shall observe fast while on duty as well as off duty. Steps shall be taken to ensure that all running staff boycott the eatery in Running Rooms and training centers. All shall wear badges. Leaflets shall be printed in regional language. All press & TV media shall be invited informed about the agitation. In order to attract public attention and to motivate those who are on duty, a sit in fast shall also be arranged at all main depots. Where ever local police prohibit to remain during night, assemble in the tend during day time. All sister trade unions and influential peoples shall be

approached for their support.

The govt. has gone back from the promise of the option to withdraw 60% of the pension fund at the time of superannuation, as it is omitted in gazette notification. Serious protest to be raised against this betrayal.

### **Divisional Conventions**

Patna BGM decided to organize conventions on the 15 point charter of demands, in every division between 10,th& 15 th February. Central leaders from neighboring zones shall be invited along with central leaders within the zone and zonal leaders

The aim of the meeting as decided by Patna BGM is to make a clarion call to all running staff, to prepare to

- 1) Stop application & release of handbrakes by ALP
- 2). Avail rest after 9 hours from sign on.
- 3) Avail night rest after second night duty.
- 4). Avail 16+30 hours as PR
- 5). Refuse to carry FSD & tools
- 6). Return to HQ after 36 hours at out station.

Divisional conventions whichever could not be conducted before the hunger fast shall be organized afterwards

### **Com. M. N. Prasad remembrance day on 11/02/25**

Remembrance day shall be observed in all depots with floral tribute and meeting at all depots. This shall be organized as a campaign programme of the hunger fast agitation too.

### **Mass demonstration at Delhi.**

Delhi March shall be conducted in second week of April, followed by CWC meeting.

### **8<sup>th</sup> VPC.**

All zonal committees shall convene a meeting in their zone, within 15<sup>th</sup> February to make a draft on the demands and its justifications for the consideration of 8 th CPC. A meeting of one or two persons from every zone shall be convened at Gaziabad for two days. The meeting shall deliberate on the subjects to be presented before pay commission, prepare the notes and shall nominate a committee to write the memorandum to 8th. CPC.

### **Meeting with AIGC for a joint agitation on mileage.**

Meeting decided to accept the proposal to form a joint platform with AIGC. This meeting shall be held at Gaziabad office in the last week of February attached to the meeting of memorandum committee.

**Delegation to minister for railways.**

During the stay at Delhi for the discussion on CPC memorandum, we shall seek an appointment with MR or CRB.

**The dates of memorandum committee meeting, Mobilization at Delhi and CWC meeting will be announced as early as possible**
