## **All The Constituents Unions & Associations Of AIFEE**

Sub:- National Convention of all Unions, Associations of NCCOEEE constituents at Nagpur on 23<sup>rd</sup> February 2025.

Comrades,

AIFEE's central office Nagpur have already informed all the office-bearers and members vide circular dtd.22<sup>nd</sup> January 25 the discussions and decisions of the meeting of NCCOEEE held at New-Delhi dtd 19<sup>th</sup> January 2025.

We the power workers and engineers are selling in a critical situation due to privatisation of Chandigarh power utility and speedy action of privatizing the 'Purvanchal & Dakshinancal Vidyut Nigam' of Utter Pradesh power sector. At Chandigarh all measures to curb the agitation is being applied by the central govt & half of the regular workforce of workers & engineers are compulsorily and forcibly retired.

Agitation at both the states are continued apposing the privatization policy of the Govt. Similar to U.P. & Chandigarh the state govt of Maharashtra, Rajasthan, Tamilnadu, Jammu & Kashmir are marching ahead to privatize the sector by applying various methods issuing instructions by circulars & meetings. The central govt has already accepted a tender bid of 6000 M.W. power generation to Adani Power. Approval of tenders of prepaid smart meters amounting to Rs 28567 croes to Genus Power & of Rs 21928 crores to Adani Transmission Ltd. Is also given for various states.

The NCCOEEE constituents has noted these actions seriously and decided to call for National Convention of all unions associations of power workers & engineers on 23<sup>rd</sup> February 25 to discuss and decide further course of action.

Primarily it was decided to hold the convention at Lucknow as the agitation is continued there. But due to not getting permission from the govt to hold such convention at Lucknow Shri Dubeji intimated the inability. Therefore after discussions it is decided to hold the convention at Nagpur on 23<sup>rd</sup> Feb.2025. NCCOEEE expect that from each state at least five office-bearers of workers & engineers should participate.

### **Our AIFEES PARTICIPATION**

All the office-bearers of central committee and all general council members of AIFEE have met in all India level general council meeting at Nagpur on 14<sup>th</sup> &15<sup>th</sup> Dec.2024 and resolved unanimously to issue One Day strike call against privatisation. Therefore practically it will not be possible for all of them once again to reach Nagpur. Despite the difficulty the central office expect that U.P. Punjab, Karnataka, Assam, Rajasthan, Goa, Tamilnadu, Kerala at least one or two office-bearers should invariably participate. Office-bearers in good numbers should participate from Maharashtra. Madya Pradesh & Chhattisgarh, Both the states are nearer to Nagpur therefore they should also participate in good number.

The convention is of one day only starting at 11 A.M. on 23<sup>rd</sup> February and will complete the business before 5 P.M. so that the participant could return on the same day.

Nagpur office have received confirmation from U.P., Karnataka, Maharashtra, Tamilnadu. Other should also follow suit and intimate me as early as possible.
