CIRCULAR

The Northern Regional constituents of National Coordination Committee of Electricity Employees and Engineers (NCCOEEE) met at Lucknow, Uttar Pradesh on 8th April 2025.

The meeting took serious note over the rampant privatisation attempt of the UP power department. The Electricity Employees are in struggle for last 130 days. Defying all attacks the employees, engineers and contractual workers are fighting valiantly to protect their public power utility.

The meeting took a strong resolution against this privatisation initiative and urged to the UP Govt. to immediately roll back this process. NCCOEEE constituents across the country will stand strong in support of the struggling UP employees and engineers. Any vindictive attack upon the UP power employees will be strongly responded all across the country by the 27 lakh powermen.

NCCOEEE endorsed the action programme adopted jointly by the struggling employees and request all its constituents to participate in the same.

The decisions are:

Date	Programme
16-30 th April 2025	Mass campaign, Consumers meet and submission of Memorandum to public representatives in all districts and projects
1 st May 2025	Observation of May Day by organizing massive motor-bike rally in all districts and project areas.
2-9 th May 2025	Relay hunger strike at Shakti Bhawan, Lucknow
14-19 th May 2025	Work to rule and demonstrations
20 th May 2025	Massive day-long demonstration in all projects and offices
21-28 th May 2025	Work Boycott: 2:00–5:00 PM with protest demonstrations
29 th May 2025 onwards	Indefinite work boycott


In spite of the serious resistance and grievances of the employees, if UP Govt. unilaterally initiate the tendering process for privatisation of PVVNL and DVVNL,

the employees and engineers will be compelled to resort to indefinite work boycott with immediate effect.

The NCCOEEE has taken further decisions to

- 1. Send representations from all northern regional states to participate in the relay hunger strike to be held from 2-9th May 2025 at Lucknow.**
- 2. All NCCOEEE constituents will ensure the submission of 20th May Strike Notice by 5th May 2025.**
- 3. Northern region NCCOEEE constituents except UP will massively demonstrate all across the region on 14th May 2025 at lunch hour in support of the struggling UP employees.**

NCCOEEE again urges to the UP Govt. to immediately halt the privatisation process and begin discussion with the struggling employees. Any further delay may create long term bearing in the entire power sector of our country.
