Sub- Preparations for 9th July strike.

Dear Comrades,

Through our earlier circular dt 18.05.2025 I have discussed and intimated the details in regard to postponement of power sector's Nation wide strike scheduled on 20th May 2025. The NCCOEEE in its virtual zoom meeting dtd 18th May 25 had unanimously decided to rescheduled the power sector National strike dates as 9th July 2025. Necessary information of this change is also given to all the constituent of AIFEE vide circular dt 18th May 25 requesting them to immediately start joint campaign. This is necessary creating atmosphere for preparation of strike and the mindset of the workforce including engineers for participation. Efforts be made at local levels also to bring all the unions on one platform for success of the strike.

It is specifically to mention here that all the Central Trade Unions have also decided and declared to observe 9th July 25 as National strike. Therefore all the public sector employees, State & Central Govt employees, Bank, LIC, Post and telegraph and many more have also decided to Join the strike. There demands are also apposing privatization of public sectors, implement old pension scheme, regularise all contract workers, declare rise to EPS-95 pensioners etc.

For preparation of all India Power sector strike of 9th July 25 AIFEE, Nagpur central office have started organising the states leadership. Our central office bearers have decided to visit the states in June 25. State units are requested to print pomplets and posters in regional languages for preparation. AIFEE'S general secretary called the meeting of Rajasthan Bijlee Workers Federation at Jaipur on 28th May 25. The meeting was attended by the prime office bearers.

Secondly the meeting of Presidents & General secretaries of 10 states was called at Jaipur on 30th May 25 to chalk out the organising plan of 9th July. The following ten states participated at Jaipur.

- 8) Com Sadyabadi Bagh:- Odisha State Electricity Employees Federation.
- 9) Com Manju Verma & Mohan Sharma:- Maharashtra State Elect. Workers Federation
- 10) Com Mohan Lal Verma :- Bhakra Beas Employees Union.

(Note): - Since the above comrades have attended Jaipur meeting they should not come to Delhi on 9th June NCCOEEE's meeting.

Some of the state's office bearers requested that the Joint tour programm of NCCOEEE's leaders should undertake to organise the strike especially at Bihar, Jharkhand, Maharashtra, Himachal, Haryana & Jammu Kashmir. General Secretary told that this particular issue will be discussed in NCCOEEE's 9th June Delhi meeting.

This 9th July Strike is essential to appose the privatization policy of the Central & state govts. The Uttar Pradesh employees, workers, contract workers & engineers are, from last 181 days jointly agitating against the state & govt & chairman's, privatization policy. Despite the historical agitation of U.P. power sector employees, neither the state govt nor the distribution companies Chairman are honestly coming forward to discuss and decide the issue amicably. We all have to realise the might of all unions of workers & engineers who are solidly fighting the cause for which they all deserve a big applause & appreciation.


If the govt succeeds in privatizing U.P. Discom, then the same policy will be repeated in all states. Therefore 9th July strike should be observed with overwhemly response to save U.P. Discom from privatization and a revolutionary message to govts to with hold the privatization policy of power sector.

The AIFEE's constituents are requested to issue the 9th July 25, strike notice on 15th June 25. The notice will be addressed to Central Govt's Power Minister, New-Delhi, U.P. Chief Minister Adityanath Jogi & U.P. Power Minister Lucknow, Chairman U.P. Power companies.

Secondly one separate set of strike notice will have to be addressed to respective states Chief Minister, Power Ministers & Chairman's of power utilities. The state's general secretaries have to issue separate strike notice to the states management i.e. Energy Minister, Chairman & others. Profarma of strike notice is enclosed herewith.

N.C.C.O.E.E.E. have also issued a detail circular on the subject. In addition to the above the U.P. power Corporation has issued a executive order amending the U.P. Power Corporations service Regulation 2020 and empowered the management to unilaterally dismiss, remove and reduce the rank of power employees and engineers who are peacefully protesting against privatization. Such a dismissal will disqualify the employees for future employment.

In view of the above ensure that the 9th July strike will be successful.

Sub:- Notice of one day Strike on 9th July 2025.

Sir,

Apropos to the decision of National Coordination Committee of Electricity Employees And Engineers (NCCOEEE) the broad based united platform of all National Federations of Electricity Employees And Engineers, we the employees of (Name of the federation/union) will resort to one day strike on 9th July 2025, in full solidarity to all the central Trade Unions all over the country, and for the long pending demands of power workers and engineers of the state.

Despite of our continued persuasion the management has failed to discuss to reach to an amicable settlement over the burning issue of stop privatization of power sector and the long pending demands of the employees. Against privatization of Uttar Pradesh power sector all the unions of workers and engineers are agitating since last 181 days and the govt & the power sector management is playing a role of mere spectator. This has compelled us to take decision of observing one day token strike on 9th July 2025 for the following demands of power sector employees and engineers.

1) Stop Privatization process of Purvanchal and Dakshinanchal Nigam of Uttar Pradesh power sector.

- 2) Withdraw all vindictive actions against the agitating employees and reinstate all the terminated samvida workers. Withdraw the draconian and undemo cratic executive order amending U.P.'s Power corporation service regulation.
- 3) Respect the provisions of settlement signed with the Uttar Pradesh Bijlee Karmachari Sangharsha Samittee.
- 4) Scrap antiworkers labour codes, ensure social security, work place safety for power employees. Withdraw Fixed Term Employment Provision
- 5) stop prepaid smart meter policy, installing 33 crores meters.
- 6) Stop introduction of TBCB mode in construction, maintenance of substations and transmission lines. Stop retrogated transmission Policy.
- 7) Resist P P O model in hydro power stations project.
- 8) Roll back gifts and monetization of assests of public sector specially of power grid, NTPC, NHPC under draconian NMP and various other pro corporate schemes.
- 9) Reduce the price of electricity, resolve coal supply issues and stop fraudulent coal import.
- 10) Role back privatization of public Sector Power utilities, cancel all existing private licenses and franchisees.
- 11) Fill in all vacant post of workers & engineers.
- 12) Regularise all contract / outsource workers as per seniority working in distribution / transmission & generation from last 10 to 15 years.
- 13) Implement Hon Supreme court's Judgement of 'Equal Pay- for Equal work'.
- 14) Implement old pension scheme for all workers & engineers.

State federation may add other important demands if any.

Since the management and the power ministry has overlooked the our requests of discussing discussion and unilaterally implementing the privatization policy The National Coordination committee of Electricity Employees And Engineers is compelled to take decision of Nationwide strike by all the worker and engineers.

This may please be treated as formal notice.
