## CIRCULAR

The National Coordination Committee of Electricity Employees and Engineers (NCCOEEE) met on 9<sup>th</sup> June 2025 at BTR Bhawan, New Delhi. Comrade Mohan Sharma presided over the meeting.

The meeting took a serious note over the ongoing privatisation process of UP Power Sector. The Employees and Engineers of UP Power Sector are struggling for last 194 days; NCCOEEE extends strong solidarity and support to the struggling UP Power sector employees. The meeting took following decisions for strict implementation by all the constituents:

1. NCCOEEE again requests UP Power department to roll-back the privatisation attempt. Any further escalation will be responded with strong action all across the country. Power Sector employees under the banner of NCCOEEE will continue to campaign rigorously in support of the UP struggle.
2. **A nationwide demonstration at all sub-stations/offices/power plants will be observed on 2<sup>nd</sup> July 2025 in support of the UP Power employees and engineers.** NCCOEEE appeals all power workers to join the movement at lunch-hour on that day.
3. NCCOEEE congratulates the Samyukt Kisan Morcha (SKM) for actively supporting the struggle of the UP Power employees. **A joint convention of Power employees, farmers and other consumers will be held on 22<sup>nd</sup> June 2025 at Lucknow, UP.**
4. In spite of this continuous agitation, if the UP Power department desperately floats the tender of privatisation, the power employees and engineers will be compelled to go for immediate strike action all across the country. The Central and UP State Govts are requested to realize the gravity of the situation and take necessary steps to roll-back the privatisation.
5. The meeting discussed in detail about the status of the Private Sector smart metering throughout the country. NCCOEEE clearly reiterates that, this smart metering is nothing but a move for further privatisation of electricity sector. Spontaneous and organized resistances are erupting at several states and some State Govts. are putting a halt to the process assessing the mood of the people. **NCCOEEE asks its constituents to unitedly campaign against this private sector smart metering project.**

6. Now, the foremost task in front of the Power Sector employees and engineers is to make the 9<sup>th</sup> July Strike a great success. This NCCOEEE meeting discussed in detail about the preparation of the strike. The following decisions have been taken in this regard:

- a) All constituent federations of NCCOEEE will ensure the submission of Strike notice by all of their constituent unions on 15<sup>th</sup> June 2025.
- b) A review of the preparation of strike will be done on 18<sup>th</sup> June 2025 meeting of NCCOEEE at Kolkata, West Bengal.
- c) To make the Strike historic and to campaign about the ongoing struggle of UP, the following regional conventions will be held.

30 <sup>th</sup> June 2025	Mumbai	Maharashtra and Gujarat
1 <sup>st</sup> July 2025	Hyderabad	Andhra and Telangana
4 <sup>th</sup> July 2025	Guwahati	Assam, Meghalaya and Tripura
<b>The Conventions should mobilise 300-400 participants; major mobilization should be from the host states. The constituent unions/associations should distribute the quota for participations among themselves.</b>		

7. The Regional Committees of NCCOEEE should start functioning actively.
