Subject: Notice of Participation in Nationwide Industrial Strike on 9 May 2025

Sir,

In accordance with the provisions of section 22 of the Industrial Disputes ac ACT, 1947, we hereby serve notice that our union will participate in the Nationwide Industrial Strike on 20 May 2025, as declared by the joint platform of Central Trade Unions and Independent Federations The strike is being called to press for the following justified and long-pending demands of the working class and common people:

- 1. Scarp the four Labour Codes which dilute hard-earned rights of the workers.
- 2. Stop Privatization of Public Sector Enterprise and Government Departments. scrap the National Monetization Pipeline (NMP).
- 3. End contractualisation and fixed-term employment; ensure regular employment for all.
- 4. Ensure a minimum wage of 26,000 per month for all workers, indexed to inflation.
- 5. Ensure minimum pension of 9,000 per month and extend universal social security to all categories of workers, including those in the unorganized sector.
- 6. Scrap the National Pension Scheme (NPS) and restore the Old Pension Scheme (OPS) for all government and PSU employees.
