Dear Sir,

The proposed Nationwide Industrial Strike – initially scheduled for 20.05.2025- will now be observed on 09.07.2025, as per the call given by the Joint Platform of central Trade Unions and Independent Federations. The All Indian N.M.D.C. Workers' Federation (AINMDCWF) would like to inform that the Non-Executive employees / Members of Affiliated Unions of AINMDCWF will observe **"ONE DAY NATIONWIDE INDUSTRIAL STRIKE"** on 09.07.2025 (Wednesday) to secure the Charter of Demands as below.

-: CHARTER OF DEMANDS -:

1. Scarp the four Labour Codes which dilute hard-earned rights of the workers.
2. Stop Privatization of Public Sector Enterprise and Government Departments. scarp the National Monetization Pipeline (NMP).
3. End contractualisation and fixed-term employment, ensure regular employment for all.
4. Stop outsourcing of core activities and violation of the Contract Labour (Regulation and Abolisation) Act,1970.
5. Ensure a minimum wage of 26,000 per month for all workers, indexed to inflation.
6. Ensure minimum pension of 9,000 per month and extend universal social security to all categories of workers, including those in the unorganized sector.
7. Scarp the National Pension Scheme (NPS) and restore the Old Pension Scheme (OPS) for all government and PSU employees.

9. Legally guarantee MSP at C2+50% as recommended by the Swaminathan commission; implement comprehensive loan waivers for distressed farmers.
10. Recognize the Right to Work as a Fundamental Right under the Constitution of India.
