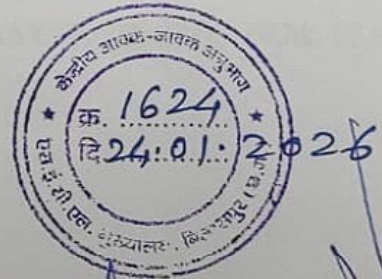





CHARTER OF DEMANDS RELATED TO WORKERS OF COAL INDUSTRY

1. Withdraw the four labour codes.
2. Stop the Privatization and contractualization of coal mines, Iron ore mines and other mines, through MDO and Revenue Sharing route. Allow the mines to run departmentally through permanent and departmental manpower.
3. Stop commercial mining of Coal Industry.
4. Stop Disinvestment or buyback of shares of Coal India or its subsidiaries. Any step to weaken Coal India and Singareni Coal Company should be stopped immediately.
5. Immediately stop the plan to separate CMPDI from Coal India.
6. Ensure the implementation of increased salary of High Power Committee for Contract Workers in Coal India and Singareni Collieries Company Limited (Ref CIL Circular No. C-B/LBCCI/HPC/566 dated 18.02.2013)
7. Ensure Implementation of employment under Clause 9.3.0, 9.4.0, 9.5.0 and 9.5.1 to 9.5.3 of Coal Wage Agreements.
8. Pay enhanced Gratuity of Rs. 20 Lacs w.e.f 01.01.2017 to retired Non-Executives at par with Executives.
